What is NCVO's Sustainable Funding Project?

The Sustainable Funding Project encourages and enables voluntary and community organisations to explore and exploit a full range of funding and financing options to develop a sustainable funding mix.

About the workshop:

This one day workshop is aimed at frontline organisations and focuses on the early stages of the learning curve of developing a sustainable funding mix - it seeks to give people the awareness, understanding, enthusiasm and information to think further.

This workshop will not provide information on sources of funds. Instead it will encourage voluntary and community organisations to explore a diverse income mix. The workshop is designed as an overview of sustainable funding, with a particular emphasis on generating income from trading goods and services.

What the workshop will cover:

- An introduction to the theme of sustainable funding
- An introduction to full-cost recovery
- An introduction to the principles of generating income through contractual work and trading goods and services
- An introduction to loan finance

What to expect:

- A mix of presentations
- Small group work
- Open discussions

Voluntary, community and faith based organisations interested in learning how to find out about different ways of sustaining their organisation.
